SAILING INSTRUCTIONS 2013

VERSION 1.0

1. RULES

- 1.1 Races will be governed by the Rules as defined in the Racing Rules of Sailing 2013-2016 (RRS)
- 1.2 The prescriptions of Sail Canada shall apply as shown in the Sail Canada RRS 2013-2016
- 1.3 Eligible yachts may be entered by completing registration at the Chester Yacht Club, including remitting proof of liability insurance to the racing committee (CYC bar)prior to racing. Multi-hulls are not eligible for racing at Chester Yacht Club.
- 1.4 The helmsperson of the participating yacht must be in compliance with Article VII of the CYC Constitution and shall be in good standing. If a visitor then shall be a member of a recognised National Sailing Authority. Trophies may only be won by eligible CYC Members, excepting those specifically open to visitors.
- 1.5 Bluenose Class rules shall be used for all Bluenose Class racing. Other classes may advise the racing committee of their desire to race under their respective class rules. When there is a conflict between a class rule and a CYC requirement such as may be found in a Deed of Gift, the latter shall prevail.

2. Notices to Competitors

- 2.1 Notices to competitors will be posted on the Official Notice Board located on the west side of the clubhouse.

3. Changes to Sailing Instructions

- 3.1 Any changes to the Sailing Instructions will be posted one hour before the race affected except that any change to the schedule will be posted by 1800 hrs before the day it will take effect.

4. Signals made ashore

- 4.1 Signals made ashore will be displayed on the signal mast on the west end of the CYC wharf.

5. Schedule of Races

- 5.1 The schedule of races is shown on the Chester Yacht Club calendar of the current year.

6. Racing Area

- 6.1 The Racing Area is defined by the sketch on the CYC Course Card of the current year.

7. The Course

- 7.1 The course to be raced will be displayed on the west side of the CYC wharf or on the Signal Boat. This may be displayed as:

- 7.2 A board marked 'CC' followed by a number - this then refers to the corresponding set course on the CYC course card, or;
- 7.3 A board marked 'M' followed by a series of numbered boards, which refer to the numbered marks on the CYC Course Card. If this is used then the colour of the numbered board indicates the side (Red/Port or Green/Starboard) on which the mark must be passed.
- 7.4 Courses displayed on the race committee boat may use either set course numbers (CC) or a series of numbers corresponding to CYC racing marks, and aids to navigation, with a P (port or S (starboard) to indicate the side on which the mark must be passed. A mark number followed by a G indicates a gate shall be present at that mark. Yachts shall pass between the marks of the gate from the windward direction.
- 7.5 For races requiring a set course such as the Inner Island race, the course to be sailed shall be available at the CYC bar no later than 2 hours before race start time.

8. Marks

- 8.1 Marks may be moored navigational aids, moored club marks which are generally yellow or laid marks which may be tetrahedrons or similar. Marks are identified on the CYC Course Card.

9. Class Flags

- 9.1 The following class flags will be used:

A Class – Red

B Class – Light blue

Free for All – Code Flag F

Classic – White

Bluenose – Class Flag: Black B on a white circle on a blue background, with red bars at either end.

Cruiser – Green

10. The Start

- 10.1 Races will be started by using Rule 26 with the warning signal being given five minutes before the Starting Signal. An Attention Signal may be given one minute before the warning signal.
- 10.2 The warning signal for each succeeding class shall be made one (1) minute after the starting signal of the preceding class unless postponed. (Not applicable to Outer Island Race start)
- 10.3 The start line will be between a staff displaying an orange flag on the Signal Boat and either Chester Rock Buoy (MAA) or a tetrahedron. When a tetrahedron is present on a bearing approximately 90 degrees to the wind direction, it shall be the pin end of the start line.
- 10.4 Yachts whose warning signal has not been made shall keep clear of the starting area and of all yachts whose warning signal has been made.
- 10.5 A Yacht starting later than five minutes after her start will be scored Did Not Start without a hearing. This changes rules A4 and A5.
- 10.6 Starts may be postponed if the Race Committee believes a starting yacht may not be in compliance with Sailing Instruction 22. When all yachts are observed to be in compliance with S.I. 22, the start may resume.

11. Changes of Course after the Start

- 11.1 Change of Course will be signalled before the leading yacht has begun the leg. Code Flag "C" will be displayed by the Signal Boat; a numbered board with the new Mark(s) will be displayed and the letter P (port) or S (starboard) to indicate the side on which the new mark must be passed.
- 11.2 Shorten Course will be carried out per Rule 32.2.

12. The Finish

- 12.1 The finish line will be between an orange staff displaying an orange flag on the Signal Boat and either Chester Rock Buoy (MAA) or a tetrahedron.
- 12.2 When both Chester Rock Buoy and a tetrahedron are present, the finish line shall be between the tetrahedron and the Signal Boat.
- 12.3 The course displayed on the RC boat at the start will show “1F ” for finishes that use an on-station signal boat.

OR

- 12.4 The finish line will be between Chester Rock Buoy (MAA) and a yellow post on the west side of the CYC wharf.
- 12.5 When this is the finish line, the course displayed on the RC boat will end with “1FS ” (leave Chester Rock Buoy to Starboard when finishing.)
- 12.6 The Race committee may make a sound signal at the finish of each boat. The presence or absence of a sound signal shall not be grounds for a right to redress by any boat. This changes rule 62.1(a).
- 12.7 A yacht shall not cross any finish line unless finishing.

13. The Penalty System

- 13.1 Rule 44.1 shall be in effect.
- 13.2 In addition, a yacht who realizes after finishing , but before protests are heard, that she has broken a rule of Part 2 while racing, may choose to accept a 20% scoring penalty as outlined in rule 44.3 (c) Such penalty shall not be less than 1 place. Acceptance of this penalty must be communicated to the RO, prior to any protests being heard.
- 13.3 For the Bluenose Class, Rule 44.1 is changed so that the Two-Turns Penalty is replaced by the One-Turn Penalty.

14. Time Limit

- 14.1 The Time Limit for afternoon races shall be six hours from the start of the first boat, class or fleet, except for the George Baker and Outer Islands Races which shall be seven hours. Yachts failing to finish within these time limits will be scored Did Not Finish without a hearing. This changes Rules 35, A4 and A5.
- 14.2 Afternoon races shall not be postponed more than 60 minutes.
- 14.3 The George Baker and Outer Islands Races shall not be postponed more than 90 minutes.
- 14.4 The Time Limit for evening races will be two hours. If the first boat finishes within the last half hour of the time limit, finishing places shall be awarded to boats finishing within one half hour of that boat. Boats failing to finish within this time limit will be scored Did Not Finish . This changes Rules 35, A4 and A5
- 14.5 Evening races shall not be postponed more than 40 minutes in June, July and August, and not more than 30 minutes in September.

15. Arbitration

- 15.1 Protests shall be written on form available at CYC and shall be delivered to the CYC bar within one hour after the last yacht in all Classes has finished.
- 15.2 Protests will be heard in order of receipt.

16. Scoring

- 16.1 The Low Point Scoring System as described in RRS Appendix A , rule A4.1 will apply.
- 16.2 Series scoring shall be as described in RRS Appendix A, rule A9.
- 16.3 If four races are scheduled for a series, three races must be completed to constitute a series. When only three races have been completed, a boat's series score will be the total of her race scores. When four races have been completed, a boat's series score will be the total of her race scores excluding her worst score.
- 16.4 If six races are scheduled for a series, four races must be completed to constitute a series. When only four races have been completed, a boat's series score will be the total of her race scores. When five or more races have been completed, a boat's series score will be the total of her race scores excluding her worst score.
- 16.5 Two Yachts starting shall constitute a Race.
- 16.6 Bluenose Class Races- If a race is abandoned for any reason, and a mark rounding order was taken at the last mark rounded by all the boats in the race (after a class minimum of 2 legs) the Race Committee may score the race based on the mark rounding order, and may include the race in any series scoring.

17. Prizes

- 17.1 Prizes may be awarded to each yacht placing first, second or third in a race or series of races with at least four boats scored.
- 17.2 When fewer than four boats are scored, the prizes may be awarded equal to one less than the number of boats scored.
- 17.3 Perpetual Trophies may be given to a member of the Club by signing a Temporary Possession form available from the Rear Commodore.

18. Retirements

- 18.1 A yacht retiring from racing, or becoming disabled shall notify the Race Committee as soon as possible by whatever means available. In no particular order, these options may be used;
- 18.2 1) Call the CYC Clubhouse (275-3747)and advise the bar staff.
- 18.3 2) Contact the Race Committee on VHF Ch 71.

19. Insurance

- 19.1 Owner/Skipper of each Yacht shall produce evidence of valid Public Liability Insurance in a minimum amount of \$1,000,000. A copy of such proof shall be filed with the Racing Committee prior to racing.

20. Handicaps

- 20.1 All yachts competing in “ Handicap Racing” must have their PHRF listed in the current NSYA list of Yachts and their PHRF. Every assistance will be given to a new CYC member /competitor in obtaining their PHRF number to permit them to participate in racing as soon as possible.
- 20.2 Yachts will be permitted to change their declared sail inventory, and their PHRF accordingly, for each series without changing their NSYA handicap. They must request the change in writing to the Racing Committee or Rear Commodore at least 7 days before the scheduled start of the first race in the series.
- 20.3 This handicap must be kept for the entire series. Any one-off races must be raced using the listed NSYA handicap.

21. Radio Communication

- 21.1 The Race Committee may, as a courtesy, broadcast information concerning the race, courses, safety or other information on VHF Ch.71.
- 21.2 The Race Committee may communicate with boats using VHF Ch 71. A boat racing, or intending to race may communicate with another boat or the Race Committee in the event of an emergency or to relay a message. This changes Rule 41.
- 21.3 The Race Committee may not respond to radio communication from individual yachts during periods of intense activity such as start sequences and finishes.
- 21.4 A yacht shall have no right to redress concerning the broadcast of any information as described above or lack of timeliness of same. This changes Rule 62.1(a).

22. Singlehanded Racing

- 22.1 Skippers racing singlehanded must wear a Personal Flotation Device when racing. This changes Rule 40.

23. Disclaimer of Liability

- 23.1 Competitors participate in racing at Chester Yacht Club entirely at their own risk. See Rule 4, Decision to Race. The organizing authority will not accept any liability for damage or injury or death sustained in conjunction with or prior to, during, or after a race.
