



## **Crane Policy 2025**

- Crane is locked and key is available by APPOINTMENT ONLY through Club Manager
- Crane to be accessed ONLY by **CYC Members in good standing**; after completing waiver & payment
- Members may use the Crane to launch and lift boats and mast stepping and for **no other purpose**.
- Crane is available to non-members registered for Chester Race Week, two days before and two days after CRW.
- Club Manager is to maintain a usage log.
- Crane usage permitted ONLY after Fee \$175.00 per boat + hst has been paid and waiver has been signed

***Important Safety Notice: The supporting structure of the stem is showing significant signs of deterioration. To protect both our infrastructure and our members, we ask that no vehicles drive onto the stem of the wharf. All vehicles must stop at the edge of the brick patio. \* To assist with launching and hauling out boats, a hand cart is available to help maneuver boats into position at the crane.***

## **CRANE GUIDELINES**

- 1) Complete and sign waiver.
- 2) Pay fee – cheques made payable to Chester Yacht Club.
- 3) Make appointment to obtain key to crane & secure work site.
- 4) No persons are permitted to operate the crane or participate in lifting operations while consuming or under the influence of alcohol.
- 5) All persons to wear appropriate safety equipment – hard hats, gloves etc.
- 6) Certify that the load does not exceed the safe working limit of the crane – 4000 lbs.
- 7) Ensure adequate personnel available – minimum two (2).
- 8) Lifts are NOT to be conducted in high winds or heavy rain conditions.
- 9) Do not stand under or allow others to work under the load until load has come to rest on its supports or blocking, with guy lines secured.
- 10) Operator is to control and be responsible for all persons within the work site at all times.
- 11) After completion of lift, crane is to be secured and key is to be returned.
- 12) A \$100.00 fee will be applied in the event the key or hard hats are not returned.

## **CRANE FEE**

- The 2025 crane fee is **\$175.00 + hst** and **PAYABLE BEFORE launching**.
- Payments by E-transfer / Cheque / Cash / Credit Card / Bar Account.
